**GENERAL ELIGIBILITY REQUIREMENTS for OGP**

---

- OGP category eligibility is based on the organization's completed year's income (not including in-kind)
- 501(c)(3) Status
  - Required for **OGP II**, **OGP 2.5** and **OGP III**
  - OGP I** applicants must show evidence of filing by February 1, 2005 and receive their own 501(c)(3) determination letter by June 1, 2005.
- Principal office in Los Angeles County
- Primary mission is to provide arts programming to the County of Los Angeles
- Board of Directors (at least 51% California residents)
- Organizations' arts education activities and programs for K-12 aged children (including activities during the summer, weekends and after-school) must meet elements of the Content Standards for California Public Schools, which include the Visual and Performing Arts Standards, <http://www.cde.ca.gov/shsd/arts/standards.htm>
- **OGP I** and **OGP II**, programming history of at least 2 consecutive years, providing services/activities in the County, open to the public
- **OGP 2.5**, **OGP III**, programming history of at least 3 consecutive years, providing services/activities in the County, open to the public

Individual artists are not eligible. Ineligible organizations include: educational Institutions that result in a degree, diploma or certificate; student groups, recreational or social organizations; city or county government agencies/departments; chapter organizations without their own 501(c)(3)/BOD; and social service organizations.

**OGP I (budgets under \$100,000) - Wednesday, December 15, 2004**
